# **Introductory APR - Platinum Advantage:**

Any existing balances on First South Financial Credit Union loan or credit card accounts are not eligible for the Introductory APR for balance transfers.

#### **Loss of Introductory APR:**

We may end your Introductory APR for purchases and apply the Penalty APR if you are 60 days late in making a payment.

## **Application of Penalty APR:**

Your APR may be increased to the disclosed Penalty APR if you are 60 days late in making a payment.

#### Installment Plan:

We may offer you an Installment Plan which allows you to pay eligible purchases or eligible amounts over time, with interest at a non-variable rate and set payment terms. You can only create an Installment Plan if you receive and accept an offer. The offer will tell you the terms available, including the APR that will apply to that Installment Plan. Your APR depends on the transaction amount and payment term length you select.

For California Borrowers, the Titanium/Edge, Flex/Rewards and Platinum Advantage are secured credit cards. Credit extended under this credit card account is secured by various personal property and money including, but not limited to: (a) any goods you purchase with this account, (b) any shares you specifically pledge as collateral for this account on a separate Pledge of Shares, (c) all shares you have in any individual or joint account with the Credit Union excluding shares in an Individual Retirement Account or in any other account that would lose special tax treatment under state or federal law, and (d) collateral securing other loans you have with the Credit Union excluding dwellings.

### Other Fees & Disclosures:

#### Late Payment Fee:

\$29.00 or the amount of the required minimum payment, whichever is less, if you are five or more days late in making a payment. In the event you fail to make a payment on time in any of the six billing cycles following the initial violation, you will be charged \$40.00 or the amount of the required minimum payment, whichever is less.

## Balance Transfer Fee (Finance Charge):

\$5.00 or 5.00% of the amount of each balance transfer, whichever is greater.

#### Cash Advance Fee (Finance Charge):

\$10.00 or 4.00% of the amount of each cash advance, whichever is greater.

#### Returned Payment Fee:

\$29.00 or the amount of the required minimum payment, whichever is less. In the event a payment is returned in the same or in any of the six billing cycles following the initial violation, you will be charged \$40.00 or the amount of the required minimum payment, whichever is less.

\$15.00.
